ADVOCACY: IN FISCAL YEAR 2024-2025, THE ADVOCACY PROGRAM CONTINUED TO PROVIDE A VOICE FOR ANIMALS BY COLLABORATING WITH LEGISLATORS AND KEY STAKEHOLDERS TO DRIVE MEANINGFUL POLICY CHANGES, STRENGTHEN LAWS THAT BENEFIT ANIMALS, AND MOBILIZE OUR COMMUNITY TO STAND BEHIND ISSUES THAT AIM TO END ANIMAL SUFFERING. DURING THE FISCAL YEAR, OUR LOBBYING EFFORTS RESULTED IN THE PASSING OF LANDMARK LEGISLATION IN WASHINGTON STATE WHICH MADE ANIMAL FIGHTING A RANKED FELONY, PLACING IT WITHIN THE STATE SENTENCING GUIDELINES; CLOSED A LOOPHOLE IN THE SECOND DEGREE ANIMAL CRUELTY STATUTE THAT HINDERED PROSECUTION OF THE MOST COMMON FORMS OF CRIMINAL NEGLECT; AND ENACTED CHANGES THAT WILL MAKE POST-CONVICTION ANIMAL BAN PROVISIONS ENFORCEABLE. OUR TEAM ALSO SUCCESSFULLY LOBBIED FOR AND SUPPORTED THREE ADDITIONAL BILLS THAT BECAME LAW, AND INITIATED GRASSROOTS ADVOCACY ACTION ALERTS TO THE COMMUNITY THAT RESULTED IN 5,290 EMAILS AND LETTERS BEING SENT TO STATE AND FEDERAL LEGISLATORS IN SUPPORT OF PROPOSED LEGISLATION THAT WOULD STRENGTHEN LEGAL PROTECTIONS FOR COMPANION AND FARMED ANIMALS AND IN OPPOSITION TO LEGISLATION THAT WOULD WEAKEN PROTECTIONS.

THE 2024 BYLAWS INTRODUCE SEVERAL NOTABLE CHANGES AND ENHANCEMENTS TO THE GOVERNANCE STRUCTURE AND OPERATIONAL POLICIES OF PASADO'S SAFE HAVEN. MOST SIGNIFICANTLY, THE TERM LIMITS FOR DIRECTORS HAVE BEEN CLARIFIED AND FORMALIZED: DIRECTORS NOW SERVE TWO-YEAR TERMS WITH A MAXIMUM OF THREE CONSECUTIVE TERMS, AFTER WHICH A MANDATORY ONE-YEAR BREAK IS REQUIRED

BEFORE POTENTIAL RE-ELECTION, RESETTING THE TERM LIMIT. THIS CONTRASTS WITH THE PREVIOUS BYLAWS, WHICH ALLOWED UNLIMITED RENEWALS UNTIL THE BOARD REACHED FULL CAPACITY, WITH TERM LIMITS ONLY DISCUSSED AS NEEDED. THE 2024 BYLAWS ALSO SPECIFY THAT FORMER DIRECTORS MAY CONTINUE TO SERVE ON COMMITTEES DURING THEIR REQUIRED BREAK IN BOARD SERVICE. ADDITIONALLY, THE ELECTION OF OFFICERS IS NOW SET FOR EVERY TWO YEARS AT THE DECEMBER MEETING, WITH OFFICERS HOLDING TWO-YEAR TERMS, WHEREAS THE PREVIOUS BYLAWS ALLOWED FOR UNLIMITED RENEWALS FOR CERTAIN OFFICER POSITIONS AND SET DIFFERENT TERM LIMITS FOR OTHERS. THE NEW BYLAWS FURTHER STRENGTHEN THE ORGANIZATION'S COMMITMENT TO DIVERSITY AND INCLUSION BY ESTABLISHING BOARD COMPOSITION GOALS: AT LEAST 30% OF BOARD MEMBERS SHOULD SELF-IDENTIFY AS VEGAN, AT LEAST 30% SHOULD NOT, AND AT LEAST 30% SHOULD SELF-IDENTIFY AS BIPOC. THESE PROVISIONS WERE NOT PRESENT IN THE 2020 BYLAWS. OTHER UPDATES INCLUDE MORE DETAILED PROCEDURES FOR REMOTE MEETINGS, EXPANDED DEFINITIONS FOR BOARD AND ADVISORY COMMITTEES, AND ENHANCED REQUIREMENTS FOR NOTICE AND REMOVAL OF DIRECTORS.
